MEET THE INSTRUCTORS

Danielle Brogley - Danielle has served as the Director of Programs for the Wood County Committee on Aging since 2002, where she is responsible for planning, organizing and implementing all recreational, health and wellness, educational and cultural programs that WCCOA offers to older adults. A graduate of the University of Windsor with a degree in Kinesiology and a certificate in Gerontology, she possesses over twenty years of experience in aging service administration and has served as the coordinator for Program Service Area 4 (PSA) program planning mentoring group.

Carmen Clutter, MS, RDN, LD - Carmen Clutter, MS, RDN, LD is the Chief in the Elder Connections Division at the Ohio Department of Aging. In this role, Carmen leads a team of population health-focused professionals dedicated to supporting statewide strategies to advance elder justice and equity and achieve optimal health and well-being for older Ohioans. Funded by the federal Older Americans Act and the State of Ohio, her team directly administers population health-based programs and supports, including supportive services, home-delivered meals, congregate meals, evidence-based disease prevention and health promotion programs, and the National Family Caregiver Support Program. Carmen received her Master of Science in Clinical Nutrition and Bachelor of Science in Human Nutrition from The Ohio State University (OSU). Carmen completed her dietetics supervised practices through OSU's Medical Dietetics program. Since 2018, Carmen has been serving as a dietetics advisory council member with the State Medical Board of Ohio.

MEET THE INSTRUCTORS

Carolyn Copus - Carolyn Copus, Executive Director, 50 North in Findlay, Ohio just completed a \$5.5 M renovation and expansion project during 2020. Carolyn was able to raise \$3.1 M for the expansion and \$2 M for the renovation. Carolyn received both her undergraduate and graduate degrees from Ohio University. She worked at The Arts Partnership for 15 years, the last 9 of which she served as Executive Director. Prior to coming to 50 North, Carolyn was employed by Blanchard Valley Health Foundation as the Major Gifts Officer and later as Director of Independent and Assisted Living at Birchaven Village Retirement Center

David Corey - is President of PACA. He earned an undergraduate degree from the University of Michigan with a double major in Economics and Communication. He also received an MBA from The Ohio State University with a concentration in Finance and Marketing.

Nancy Dzurmak - Nancy Dzurmaki is the Program Manager for Greater Cleveland Volunteers. Greater Cleveland Volunteers is a non-profit organization that recruits and matches the skills and talents of volunteers, ages 18 and older, to over 100 non-profit agencies in the Greater Cleveland area. She manages the AmeriCorps Seniors RSVP and Community Volunteers Programs which includes developing and maintaining partnerships with non-profit agencies who require volunteers to assist with their mission. In addition to working with non-profit partnerships, she works on encouraging, engaging, and informing volunteers of opportunities to serve our community through volunteering.

Anahita Feltz - Anahita is the manager of Silver Linings at Old Bridge, a Nationally Accredited Activity Center for Adults 60+ in New Jersey. She serves on the Best Practices Committee and is the chair of the Membership Committee for the National Institute of Senior Centers, while also being the NJ representative for the NISC Leadership collaborative. She also serves on the board of the NCOA's "Modernizing Senior Centers Resource Center". Locally, she serves as the co-chair of the Active Adult Committee of the New Jersey Recreation and Parks Association. She is in the process of reviving a State Association of Senior Centers in New Jersey in 2023. ON her downtime, she enjoys hiking, rock climbing, playing tennis, cooking and volunteering.

Stephanie FallCreek, MSW, DSW, LCSW - Stephanie served for 30 years as President/CEO of Fairhill Partners, a unique social purpose real estate campus in Cleveland, Ohio with more than 50 independent for profit and not for profit collaborative tenant partners. Currently "semi-retired," she is taking on a few consulting jobs in areas that ignite her passion. FallCreek is best known for her work in health promotion and organizational development. Dr. FallCreek is a T-Trainer, Master Trainer, Leader and Coach for multiple licensed, evidence-based self-management programs. Dr. FallCreek earned her Master's Degree and Doctorate at the School of Social Welfare, University of California, Berkeley. She has 47+ years' experience working with community based organizations to deliver participant responsive and effective programming to improve social and health equity with diverse populations. Mother, grandmother (of thirteen, aunt, sister, daughter, friend, and married to Jerry Tillman for 34 years, Fall-Creek is devoted to her faith, family, friends and community service.

Haraz N. Ghanbari - is a State Representative from Perrysburg, Ohio and is serving in his second term in the Ohio House of Representatives. Haraz has dedicated his life to serving others and has more than two decades of military service.

Bryan Glover - In 1993, Bryan and his wife Kelly left Ohio and moved to Toccoa, Georgia, where he attended Toccoa Falls College. Upon completion of his psychology degree, Bryan, Kelly and their daughter, Emily returned to Ohio where Bryan took a position as the Social Services Manager at the Seneca County Commission On Aging in June of 1997. Due to the sudden death of the Interim Director, Bryan was named Executive Director in August of that year and has served in that capacity since. During his time at the Commission On Aging, the agency has grown in every service area and increased its overall revenue by over 600%. Service offerings include nutrition based services, home repair and modification, private catering and hall rentals, transportation and senior housing. Currently, the Seneca County Commission On Aging provides hot daily meal service to Seneca, Wyandot, Richland, Morrow and Marion Counties and frozen meal service through its Home Style Selections program in nineteen counties throughout Northwest Ohio. In addition to his duties as Executive Director, Bryan also serves on the Ohio Association of Senior Centers Board of Directors (president 2006 – 2008), E.C.I., Inc. (a for profit company serving the mentally disabled throughout Ohio), and the Julia Weller Commission.

MEET THE INSTRUCTORS

Adrienne Green, MSW, LISW-S - Adrienne is a 25-year veteran of service for older adults. Her work has spanned a variety of settings, from adult protective services, hospital-based geriatric psychiatry, senior social services, to community mental health for older adults. She has a passion for education around the specialized needs of older adults, and is a fierce advocate for access to services that enhance quality of life. Adrienne is currently the Director of Geriatric Services at Signature Health, a provider of integrated services including mental health, addiction recovery, primary care, and infectious disease care to individuals of all ages. Signature Health has 6 clinics in 3 counties in Northeast Ohio.

Morgan Fitzgerald, MPH, CHES - Morgan is the Planning and Operations Section Chief of the Ohio Department of Aging's (ODA) Elder Connections Division. Morgan joined the department in 2020 to manage the State Plan and Area Plans, and she now oversees the section leading all strategic planning, operations, and reporting efforts for Older Americans Act and related programs. As an author of Ohio's 2020-2022 Strategic Action Plan on Aging (SAPA) and Ohio's 2023-2026 State Plan on Aging, Morgan strives to ensure quality, compliance, elder justice, and equity are integrated into all programs, services, and policies administered by the division. Morgan is passionate about prioritizing the needs of underrepresented communities and establishing a plan to institute systemic changes that eliminate disparities and inequities among older adults and caregivers. Prior to her role at ODA, Morgan worked for 10 years at The Ohio State University Wexner Medical Center managing a variety of clinical, non-clinical, and health policy projects. Morgan has subject matter expertise in areas including cognitive neurology, cancer control and prevention, rural health, vaccinations, chronic conditions, quality improvement, and patient safety. Morgan is a Certified Health Education Specialist and received both a bachelor's degree in health sciences and a master's degree in public health from The Ohio State University.

Raymont Harris, Coach, Consultant, Speaker

Raymont Harris is an Entrepreneur, Professional Speaker, Coach and Consultant that founded Elite Mindset Performance (EMP). Born in a small steel city outside of Cleveland, Ohio called Lorain, Raymont was raised alongside his older brother and sister by his widowed father. Raymont, from the very early days of his life was faced with extreme challenges that have greatly shaped the man he is today. Former NFL player, by the way of The Ohio State University, Raymont has spent the past fifteen years working hand in hand with coaches, staff and athletes inside one of the most premier athletic departments in the country. He has guided C-Suite and senior level executives, advised entrepreneurs on growth, flexibility, effective leadership and communication. He has empowered the lives of countless people.

Connie Huntsman - Connie is the Executive Director of the O'Neill Senior Center and has been with the organization since 1997. She has been involved in all program development and capital projects undertaken by the O'Neill Center and is currently certified as an Administrator on Aging Services through the [Ohio Association of Senior Centers](#) and serves as the current Past President of the Ohio Association of Senior Centers.

Beth Kowalczyk, JD, BA - Beth Kowalczyk is the Chief Policy Officer for the Ohio Association of Area Agencies on Aging (o4a). As Chief Policy Officer for o4a, she ensures that the Ohio Area Agencies on Aging and the older Ohioans they serve have a voice at the Ohio Statehouse, with members of Congress and with state and federal agencies through the legislative and regulatory process. She serves on the Boards of the HealthPath Foundation of Ohio and the Ohio Coalition for Adult Protective Services. Prior to joining o4a, Ms. Kowalczyk was the Bureau Chief for Family Assistance Policy at the Ohio Department of Job and Family Services. She started her career with Southeastern Ohio Legal Services representing low-income Ohioans in civil matters and then joined Ohio State Legal Services Association (now known as the Ohio Poverty Law Center) as the statewide legal services advocate and expert on public assistance and workforce development programs. Ms. Kowalczyk is also serving her second term as a member of City Council in Worthington, Ohio. She has a Bachelor of Arts degree from Kent State University and a Juris Doctorate from New York University School of Law. She was admitted to the Ohio Bar in 1993.

Denise Niese - Denise Niese has served as the Executive Director of the Wood County Committee on Aging since 2005. Before her employment at WCCOA, Denise was employed for 18 years by the Area Office on Aging of Northwestern Ohio as a Program Director. She has a BA in Management and Organizational Development with a minor in Gerontology. An advocate for older adults, Denise is the Past President of the Ohio Association of Senior Centers, and served as Treasurer for the National Council on Aging/National Institute of Senior Centers Delegate Council. Denise was recognized by the Ohio Association of Gerontology and Education as the 2012 OAGE Practitioner of the Year.
